PACKAGING INSTRUCTIONS TO RETURN A JEROME FOR REPAIR OR CALIBRATION

RUSH SERVICE MUST BE INDICATED ON THIS FORM AND CLEARLY MARKED ON THE OUTSIDE OF YOUR SHIPPING PACKAGE. ALL INSTRUMENTS RETURNED FOR REPAIR REQUIRE A RETURN AUTHORIZATION NUMBER.

Using these instructions, return the Jerome to the attention of the Repair Department (see address below).


Please call our Repair Department for a Return Authorization Number. Failure to do so may delay the repair process.

- Remove and return FTM repairs by removing the perm tube from the FTM and return perm tube shipped in original canister. Perm tube must ship with the instrument.
- Include SDS sheets for all hazardous materials tested with this instrument, after approval to ship the unit.
- Pack the instrument in its original case. Cases are available for immediate shipment from Brookfield. If you do not have a case, you may ship Jerome in any box as long as they have enough material to snuggly support it. Avoid using foam peanuts or shredded paper.
- Do not ship any accessories or accessory kits as AMETEK Brookfield is not responsible for lost or missing items. Accessories include: manuals, probes, power cables, probes, etc.


